#### What is my Investment?

The annual membership investment is based on the number of fulltime (or full-time equivalent) employees, including regular employees, owners, managers, licensees, agents and commissioned sales people. Member businesses with multiple outlets, but having the same name and under the same ownership may re-enroll each outlet by combining the number of full time equivalent employees for all outlets. Owners of multiple businesses with different names must enroll each business separately.

### Investment Schedule

The chart below gives annual investment amounts based on the average number of full-time equivalent (FTE) employees. Calculation of FTE's is as follows: full time staff count as one FTE each and part time staff as hours worked divided by full time hours.

1 to 5 average FTE's	\$150
6 to 25 average FTE's	\$200
26 to 50 average FTE's	\$300
51 to 100 average FTE's	\$500
101 to 300 average FTE's	\$700
301 to 500 average FTE's	\$900
500 + average FTE's	\$1000
Government	Separate Schedule
Individuals (non business)	\$75
IRS 501(c)(3) Not for Profit (less than 20 FTE's)	\$100
